Recommended extracurricular activities and experiences: Alpha Phi Sigma Criminal Justice Honor Society, study abroad, other community involvement, and equity, diversity and inclusion (EDI) experiences such as a student association or club, volunteering in the community, or other experiences that expose you to communities and cultivate a service-minded perspective.

Internship: Internships at Sheriff's Offices, within community corrections, parole, youth detention centers, nonprofits that focus on reentry or similar would be beneficial.

Duties and Responsibilities: Corrections officers guard correctional facilities, enforce rules and policies within jails or prisons, keep order, prevent assaults and other violent or unallowed activities, supervise those in custody, inspect the facility to ensure safety and security standards are met, conduct searches on inmate,

visitors, cells, etc., report on activities outside of normal facility activities, report rule violations, escort and transport those in custody between facility, courtrooms, or others.

Work Environment: Corrections Officers assume some level of risk in this position, and injury or illness is possible. Often this career can be stressful. Shifts may be indoors or outdoors during all seasons.

Work Schedule: Shift work covers all hours of the day and night.

Career Path/Promotion: Advancement to lead, supervisory or administrative roles are possible depending on education and experience.

Education, Training and Certification: State agencies often require at least a High-school diploma at base level, plus on-the-job training after assignment to a facility. Bachelor's degree yields greater opportunity for advancement and administrative roles and is required for federal facilities.

Special Considerations: Many states have an age requirement, and on-the-job training or a similar training program to a police academy may be required depending on the state or federal facility.

Skills and Competencies: Communication, problem-solving, critical thinking, observation, conflict resolution, interpersonal communication, active listening, physical capability to some extent.
